I am a Full Time Private Consultant Surgeon with a special interest in Trauma and Orthopaedic Surgery at the Sport and Orthopaedic Clinic, BUPA Hospital Bristol with a sub specialty interest in complex knee surgery and lower limb reconstruction, hand surgery and infection control. I have extensive experience in all aspects of core Trauma and Orthopaedic Surgery with up to date experience in the management of Musculoskeletal Trauma.

I currently receive more than 500 referrals from General Practice each year. I am experienced at revision of failed knee surgery. Over the last seven years I have continued to attend conferences involving complex knee and hand disorders and their reconstruction in order to keep abreast with the latest advances and techniques.

I now have 25 years of experience in the management of Orthopaedic Trauma. In the last 12 years as a consultant I have maintained my interest in operative trauma fixation, external fixation, and the techniques of locked intramedullary nailing. With this experience I have continued to have enthusiasm, not only for the clinical management of fractures, but also for the management and organisation of trauma services. I have published widely on the science of trauma and some aspects of trauma management in particular on the management of tibial fracture and infection control.

MEDICO-LEGAL EXPERIENCE

The preparation of expert medical reports for patients involved in personal injury claims has been part of my work and training since 1994. This work has given me insight into the management of complaints and complications. My Medico-Legal Reports are prepared according to the guidelines introduced by the Law Society and the British Orthopaedic Association and conform to Lord Woolf's reforms. I act equally without bias for plaintiffs and defendants and prepare reports for my own trust without charge. I have attended court on a number of occasions as an expert witness.

My research interests are diverse and range from the field of trauma management and fracture repair to infection control.
